I. Welcome and Introductions	Tim Marshall and Ann Dagle welcomed the group and initiated introductions	
II. Presentations <i>Trends in Emergency Department Visits by Young Adults for Suicide Attempts in Connecticut, 2011-2015</i> Elizabeth McOsker, Jordan Porco Foundation	Elizabeth McOsker presented on her research regarding hospitalization non-admit data in CT hospitals. Background statistics as well as an overview of risk and protective factors were included. Data was differentiated using coding for intentional self-harm, undetermined intent, suicide ideation, and encounters including both a diagnosed case of depression or anxiety (for example) paired with particular types of injuries. Ultimately, 9,746 assumed suicide attempts of the 15-24 age group were determined out of the over 9 million encounters presented. Results of interest included higher attempts without admission in the 15-19 group than the 20-24 group and that attempts by females in the 15-19 group were almost double those of males in the same age group for each year the data was reported. Implications for practice included non-admit data is 3-4 times higher than the admissions data suggesting vast attempts by young adults are not using highly lethal means and that means restriction is essential for intervention with young people. They have expressed interest in a PDF version of some documents. • The group discussed a need to rethink their approach moving forward without the RACs. <p>Lethal Means</p> <ul style="list-style-type: none"> • A representative from DOT called into the last meeting. • Dr. Sally Spencer-Thomas called into the meeting a presented helpful data regarding railroads as a lethal mean including access, signage, the people who are using railroads to die by suicide and conversations around media and safe messaging. • A total of 8 signs (4 on each side) will be ordered for the Arrigoni Bridge that will fit DOT standards and include safe messaging. • Bill Brassard of the NSSF called into the last meeting and a discussion was had around the AFSP materials that will be rolled out and how the state effort should fit within those materials.
