QPR stands for Question, Persuade, and Refer-Three simple steps that anyone can learn to help save a life from suicide. Just as people trained in CPR and the Heimlich Maneuver help save thousands of lives each year, people trained in QPR learn how to recognize the warning signs of a suicide crisis and how to question, persuade, and refer someone to help. Each year thousands of Americans, like you, are saying "Yes" to saving the life of a friend, colleague, sibling, or neighbor. Risk Assessment - Suicide Risk Assessment is to assist clinicians in all areas to make an assessment and care decisions regarding patients who present with suicidal ideation or provide reason to believe that there is cause for concern. www.mentalhealth.va.gov/docs/Suicide Risk Assessment Guide.doc

Safety Planning-Teaching patients adaptive skills to help them cope with a future suicidal crisis is necessary to keep them safe. A safety plan (Stanley & Brown, 2011) or a crisis plan should be developed collaboratively with each suicidal patient and updated as needed.

Nomenclature-The field of Suicidology has long struggled with the lack of a universally agreed upon definition for suicide and associated terms. Synonymous with the word suicide is the term self-directed violence. A shared understanding of self-directed violence (SDV) in its various forms is critical. The VA is adopting the Centers for Disease Control and Prevention (CDC)'s Self-Directed Violence Classification System (SDVCS). http://www.mirecc.va.gov/visn19/education/nomenclature.asp
