Presentation:  Nina Rovinelli Heller, PhD University of Connecticut School of Social Work  Introduction to the Psychological Autopsy	<ul> <li>Introduction to the Psychological Autopsy:         <ul> <li>Dr. Heller completed a two-day training on psychological autopsy two years ago with the American Association of Suicidology (AAS). A psychological autopsy seeks to answer why a suicide occurred, what could have happened differently, and what we can learn to help prevent suicides. Psychological autopsies provide a formalized way to get answers to those questions. The psychological autopsy is a postmortem investigative procedure to reconstruct the circumstances of the decedent and the behaviors and events surrounding death.</li> <li>The Department of Defense contracted with the AAS to perform psychological autopsies on Marines who died by suicide from 2010-2012. Data is being analyzed for 16 cases in order to inform future suicide prevention efforts of the United States Marine Corps.</li> <li>The psychological autopsy develops a psychological biography and reconstructs the last days and hours.
