Updates on State Plan and CTSAB, State Grants	Presentation, Updates on the State Plan, CTSAB, & State Grants – Allyson Nadeau State Plan 2025: Data collection and feedback are complete. The State Plan Steering Committee continues to work on synthesizing and drafting all the elements of the State Plan. We continue to meet and review any changes to work tasks and timeline in light of the pandemic however, the State Plan project is still on schedule as planned. Allyson thanked the group for their participation and is thankful for the support of the numerous participants that supported so many face-to-face feedback sessions in addition to many telephonic key informant interviews. Potential SAMHSA Grants: There are a couple of federal grant opportunities that we are waiting to hear about. We are cautiously optimistic and planning as if CT is awarded one or both grants. The grants are: 1) The NSSP: CT Networks of Care for Adult Suicide Prevention (NCASP) Grant: a) Will involve the 5 Regional Behavioral Health Action Organizations/Regional Suicide Advisory Boards, United Way/211, mobile crisis (adult and child), and the Zero Suicide Learning Community b) 25 years old + c) Enhance mobile crisis and call-center operations to increase provider coordination, use of evidence-based practices and strategies for connecting to community-based resources to prevent suicide and to reduce ED/IP stays d) Strengthen regional/community partnerships, and capacity, to support mental health promotion, suicide prevention, intervention, and response (SPIR) e) Zero Suicide: support and engage health and behavioral healthcare systems use of the ZS framework f) Ther will be a peer support component to the call center The grant is 400k annually @ 3 years (08/30/20 – 08/29/20)
