Postvention support can reduce this risk by providing support, avoiding unsafe messages or gatherings and can guide funeral activities. Safe messaging: Promote National Suicide Prevention Lifeline Warning Signs

Reports	 Grant Initiatives 988 Grant Update Thanks to United Way, CT is improving answer rate, by increasing staff coverage, looking forward to continued climb Completed one-year planning grant, awaiting the implementation awards, any day Andrea and Jeanette working on draft of a webpage for 988, not promoting yet but informational page, going live within the next week Continued enhancements being made to mobile crisis, in preparation for the soft launch this July and full launch next July DCF making investments to move child mobile crisis system to 24/7 and procuring for one urgent crisis center 24/7, designed to be less than 23-hour stay, mental health assessment within 3 hours and referral out to treatment Accompanying procurement with that would be beds for sub-acute crisis stabilization, 1-14 days On the adult side, DMHAS is preparing for similar capacity expansion At this time there is still an embargo on advertising for 988, in many states if you call 988 you will be put through to the call center, but at this time no advertising
